NorthCoast Community Woodshop, LLC. Release and Waiver of Liability

This Release and Waiver of Liability (the "Release") is executed this ____ day of ______, 20___ by the undersigned.

- 1. Assumption of Risks. I wish to use the facilities and equipment made available by, and participate in activities organized by, North Coast Community Woodshop, LLC ("NCCW"), including but not limited to the use of manual and powered cutting tools and machines for construction, and loading and unloading of heavy items. I understand that such use and participation may expose me to risks of injury, death or loss of personal property. I fully accept and assume all such risks, and all responsibility for losses, costs and damages incurred as a result of such use and participation. I also understand and agree that NCCW does not assume, and expressly disclaims, any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance, in the event of such injury, death or loss of personal property due to such risks. I further understand that I am encouraged by NCCW to carry such insurance.
- 2. Waiver and Release; Indemnification. I hereby release, discharge and covenant not to sue NCCW, its directors and officers (either in their capacities as such or their individual capacities), managers, employees, agents, volunteers, members, and other participants ("Releasees") from any liabilities, losses, costs or damages caused by or alleged to have been caused by the Releasees, including but not limited to those caused by rescue operations, including but not limited to first-aid treatment or other medical services rendered by the Releasees. I further agree to indemnify and hold harmless the Releasees from any claims made by third parties for any such liabilities, losses, costs or damages.
- **3. Photographic Release.** I grant and convey unto NCCW all rights, title, and interest in any and all photographic images and video or audio recordings made by NCCW during my activities with NCCW, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
- 4. Other. I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Ohio, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Ohio. I agree that, if any provision of this Release is held to be invalid by any court of competent jurisdiction, the invalidity of such provision shall not otherwise affect the remaining provisions of this Release, which shall continue to be enforceable.
